ANDHRA PRADESH ACTS, ORDINANCES AND REGULATIONS Etc.,

The following Act of the Andhra Pradesh Legislature received the assent of the Governor on the 30th January, 2023 and the said assent is hereby first published on the 1st February, 2023 in the Andhra Pradesh Gazette for general information:

ACT No. 1 of 2023

AN ACT FURTHER TO AMEND THE ANDHRA PRADESH CHARITABLE AND HINDU RELIGIOUS INSTITUTIONS AND ENDOWMENTS ACT, 1987.

Be it enacted by the legislature of the State of Andhra Pradesh in the Seventy fourth Year of the Republic of India as follows:-

1. (1) This Act may be called the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments (Amendment) Act, 2022.

Short title and Commencement

- (2) It shall be deemed to have come into force with effect from 15th September, 2021.
- 2. In the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987 (hereinafter referred to as the Principal Act), after section 97-B, the following new sections shall be added, namely,-

Insertion of new sections 97-C,97-D. Act 30 of 1987.

Nomination of special invitees to TTD Board and their terms and functions.

- "97-C. (1) Special invitees to Tirumala Titupati Devasthanams Board shall be nominated by the Government with such number of persons, not exceeding five, as the Government may deem fit.
- (2) (i) The special invitees shall tender advice to TTD Board for effective functioning of the Board.
- (ii) The special invitees will not have any voting right, in the meetings of the Board.

- (iii) The term of special invitees to TTD Board shall be coterminous with the tenure of the TTD Board.
- (iv) Their privileges shall be prescribed by the Government from time to time.
- (v) Any person who incurs disqualification under Section 19(1) of the Act is not eligible to be nominated as Special invitee.

Nomination of special invitees to Tirumala Titupati Devesthanams and their terms and functions.

- 97-D. (1) Special invitees to Tirumala Titupati Devasthanams shall be nominated by the Government with such number of persons, not exceeding fifty, as the Government may deem fit.
- (2) (i) The special invitees shall tender advice to Tirumala Titupati Devasthanams for welfare of devotees / pilgrims and in providing facilities to them.
- (ii) The tenure of the Invitees to the Devasthanams shall be coterminous with the TTD Board. The terms and privileges shall be as prescribed by the Government from time to time.
- (iii) Any person who incurs a disqualification under Section 19(1) of the Act is not eligible to be nominated as-Special invitee.".
- 3. In the principal Act, in section 103,-
- (1) in the sub-heading, after the word "Member", the words "or Special Invitee of Tirumala Titupati Devasthanams Board or Tirumala Titupati Devasthanams" shall be inserted.
- (2) in sub-section (1), after the words "ex-officio member", the words "or a special Invitee of Tirumala Titupati Devasthanams Board or Tirumala Titupati Devasthanams" shall be inserted.
- Tirumala Titupati Devasthanams" shall be inserted.

 (3) in sub-section (2), after the words "the member", the words "or the Special invitee of Tirumala Titupati Devasthanams Board or Tirumala
- Titupati Devasthanams" shall be added.

 4. (1) The Andhra Pradesh 'Charitable and Hindu Religious Institutions and Endowments (Amendment) Ordinance, 2022 is hereby repealed.
- (2) Notwithstanding such repeal, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under this Act.
