**ANDHRA PRADESH ACTS, ORDINANCES AND
REGULATIONS Etc.,**

The following Act of the Andhra Pradesh Legislature received the assent of the Governor on the 31st May, 2021 and the said assent is hereby first published on the 31st May, 2021 in the Andhra Pradesh Gazette for general information :

ACT No. 3 of 2021.

AN ACT TO AUTHORISE THE APPROPRIATION OF CERTAIN FURTHER MONEYS FROM AND OUT OF THE CONSOLIDATED FUND OF THE STATE OF ANDHRA PRADESH FOR THE SERVICES OF THE FINANCIAL YEAR WHICH COMMENCED ON THE 1st APRIL, 2020.

Be it enacted by the Legislature of the State of Andhra Pradesh in the Seventy-second Year of the Republic of India as follows: -

1. This Act may be called the Andhra Pradesh Appropriation (No.2) Act, 2021.
2. The State Government may appropriate from and out of the Consolidated Fund of the State of Andhra Pradesh, for the Financial Year which commenced on the 1st April, 2020, a further sum not exceeding Rs. 7955,66,62,000/- (Rupees seven thousand nine hundred fifty five crores, sixty six lakhs and sixty two thousand) being moneys required to meet,-

Short Title .

Authorization of supplementary appropriation of moneys Rs. 7955,66,62,000/- from and out of the Consolidated Fund of the State of Andhra Pradesh for the Financial Year which commenced on the 1st April, 2020.

- (a) the supplementary grants made by the Andhra Pradesh Legislative Assembly for that year, for further expenditure as set forth in Column (3) of the schedule i.e., sums not exceeding Rs.7942,07,16,000/- ; and
- (b) the Supplementary expenditure charged on the Consolidated Fund of the State of Andhra Pradesh as set forth in Column (4) of the Schedule i.e., sums not exceeding Rs. 13,59,46,000/-for the services and purposes mentioned in the said Schedule in relation to the year 2020-21.

Appropriation. **3.** The sums authorized to be appropriated from and out of the Consolidated Fund of the State by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
