**ANDHRA PRADESH ACTS, ORDINANCES AND  
 REGULATIONS Etc.,**

The following Act of the Andhra Pradesh Legislature received the assent of the Governor on the 17<sup>th</sup> December, 2021 and the said assent is hereby first published on the 20<sup>th</sup> December, 2021 in the Andhra Pradesh Gazette for general information :

**ACT No. 15 of 2021.**

**AN ACT TO AMEND THE ANDHRA PRADESH SELF HELP GROUPS (SHG)  
 WOMEN CO-CONTRIBUTORY PENSION ACT, 2009.**

Be it enacted by the Legislature of the State of Andhra Pradesh in the Seventy second year of the Republic of India, as follows:-

1. (1) This Act may be called the Andhra Pradesh Self Help Groups (SHG) Women Co-contributory Pension (Amendment) Act, 2021. Short title and commencement.
- (2) It shall be deemed to have come into force with effect on and from the 20<sup>th</sup> October, 2021.
2. In the Andhra Pradesh Self Help Groups (SHG) Women Co-contributory Pension Act, 2009 (hereinafter referred to as the principal Act), in section 2, clauses (a) and (k) shall be omitted. Amendment of section 2.  
Act No. 2 of 2009.
3. In the principal Act, in section 4, for sub-section (4) the following shall be substituted, namely,- Amendment of section 4.

“(4) The Government, through its Nodal Implementation Agency, shall ensure that the subscriber is paid pension on retirement.”.



Amendment of  
section 7.

4. In the principal Act, in section 7, in sub-section (2),-
- (i) for clause (b), the following shall be substituted, namely,-  
“(b) laying down norms for collection and accounting of contributions;”.
  - (ii) for clause (c), the following shall be substituted, namely,-  
“(c) standardizing dissemination of information about the scheme;”.
  - (iii) clauses (d) and (e) shall be omitted;
  - (iv) in clause (f), after the words “information from subscribers,” the following words shall be omitted, namely,-  
“transmitting information and fund to pension fund manager”.

Amendment of  
section 10.

5. In the principal Act, in section 10, after the words and expression “nodal implementing agency,” the words and expression “pension fund managers,” shall be omitted.

Repeal and Savings.

Ordinance No. 18  
of 2021.

6. (1) The Andhra Pradesh Self Help Groups (SHG) Women Co-contributory Pension (Amendment) Ordinance, 2021 is hereby repealed.
- (2) Notwithstanding such repeal, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under this Act.
