The following Act of the Andhra Pradesh Legislature received the assent of the Governor on the 8th April, 2022 and the said assent is hereby first published on the 4th May, 2022 in the Andhra Pradesh Gazette for general information:

ACT No. 10 of 2022.

AN ACT FURTHER TO AMEND THE ANDHRA PRADESH VALUE ADDED TAX ACT, 2005.

Be it enacted by the Legislature of the State of Andhra Pradesh in the Seventy Third Year of the Republic of India as follows,-

- (1) This Act may be called the Andhra Pradesh Value Added Tax Short title and commencement. (Amendment) Act, 2022.
 - (2) section 2 shall be deemed to have come into force on and from 19.12.2021.
- In the Andhra Pradesh Value Added Tax Act, 2005, in Schedule VI, in Amendment to Schedule VI. the Table, for Item Nos.l-A,l-B, 1-C and 1-D and corresponding entries, the following shall be substituted, namely,-
