**ANDHRA PRADESH ACTS, ORDINANCES AND
REGULATIONS ETC.,**

The following Act of the Andhra Pradesh Legislature received the assent of the Governor on the 5th March, 2024 and the said assent is hereby first published on the 6th March, 2024 in the Andhra Pradesh Gazette for general information :

ACT No. 9 of 2024

AN ACT TO AUTHORISE THE APPROPRIATION OF CERTAIN FURTHER MONEYS FROM AND OUT OF THE CONSOLIDATED FUND OF THE STATE OF ANDHRA PRADESH FOR THE SERVICES OF THE FINANCIAL YEAR WHICH COMMENCED ON THE 1st APRIL, 2023.

Be it enacted by the Legislature of the State of Andhra Pradesh in the Seventy-Fifth Year of the Republic of India as follows:-

Short Title.

1. This Act may be called the Andhra Pradesh Appropriation (No.2) Act, 2024.

Authorization of supplementary appropriation of moneys Rs.35978,16,20,000 from and out of the Consolidated Fund of the State of Andhra Pradesh for the financial year which commenced on the 1st April, 2023.

2. The State Government may appropriate from and out of the Consolidated Fund of the State of Andhra Pradesh, for the Financial Year which commenced on the 1st April, 2023, a further sum not exceeding thirty five thousand nine hundred seventy eight crores, sixteen lakhs and twenty thousand rupees being moneys required to meet, -

(a) the supplementary grants made by the Andhra Pradesh Legislative Assembly for that year, as set-forth in column (3) of the Schedule; and

(b) the supplementary expenditure charged on the Consolidated Fund of the State of Andhra Pradesh for that year, as set forth in column (4) of the Schedule;

Appropriation.

3. The sums authorized to be appropriated from and out of the Consolidated Fund of the State by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.

STATEMENT OF OBJECTS AND REASONS

The Bill is introduced in pursuance of article 205 of the Constitution of India read with article 204 (1) thereof, to provide for the appropriation out of the Consolidated Fund of the State of Andhra Pradesh of the moneys required to meet, -

(a) the supplementary grants made by the Andhra Pradesh Legislative Assembly for the expenditure of the State Government for the Financial Year which commenced on the 1st April, 2023; and

(b) the supplementary expenditure charged on the said Fund for that year.
